CAMP DIRECTOR

Stephanie Radecki just completed her fourth season as UNA's head volleyball coach. The 2007 season marked a record year for Radecki as she accomplished 100 wins in her career as head coach at UNA and finished her fourth 20+ win season. In 2006, the 35-6 lions finished the season as NCAA Division II National Runner-Up. The squad had six different players win post-season recognition, including three All-Americans, while Radecki earned Coach of the Year honors.
